

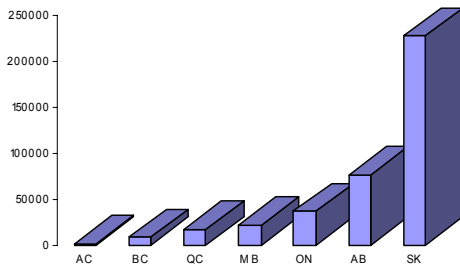

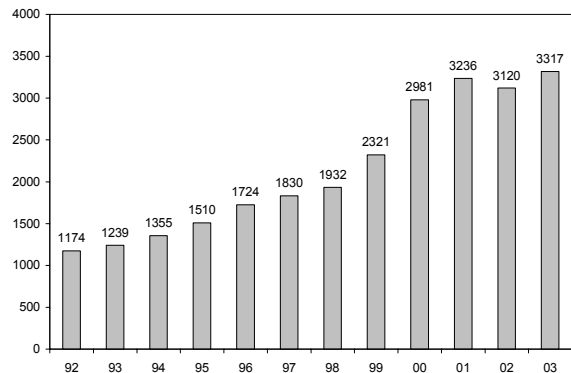

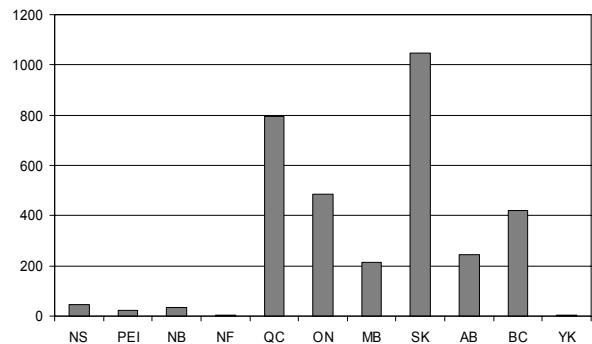

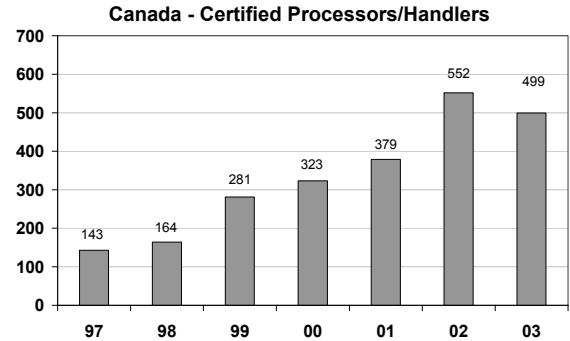

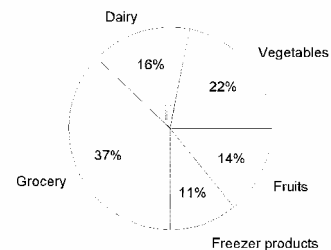
## DOMESTIC SALES

Total sales unknown; data provided for the survey accounted for \$219,410,042 of retail sales in 2003. The total is likely to be at least twice that and closer to \$800M than the higher estimates quoted in previous studies.

Canadian Origin: Produce 22%, Grocery 10%; Dairy 90%

In Atlantic Canada 2003 organic produce sales are 1.3% of total fresh fruit and 1% of total vegetables. (source: ACORN Organic Market Research & Action Plan).
